Subject: Proposed Amendments for Title 8, California Code of Regulations, Construction Safety Orders, Section 1630, Elevators for Hoisting Workers, Day 2.

The Occupational Safety and Health Standards Board (Board) staff is convening Day 2 of an advisory committee (AC) to discuss amendments to section 1630, Elevators for Hoisting Workers. The AC is in response to the Board's decision to grant Petition 587 (Zampa and McClelland), and a previous Request for New, or Change in Existing, Safety Order (Form 9) from the Division of Occupational Safety and Health (Cal/OSHA) dated April 3, 2019.

The purpose of the meeting will be to continue discussions on revisions to section 1630 based upon the requests of the Petitioners and Cal/OSHA, and follow-up discussions with affected stakeholders. The AC meeting will be held:
