# SUMMARY PUBLIC MEETING AND BUSINESS MEETING December 17, 2020 Teleconference in Sacramento, California

### I. CALL TO ORDER AND INTRODUCTIONS

Chairman Dave Thomas called the Public Meeting of the Occupational Safety and Health Standards Board (Board) to order at 10:00 a.m., December 17, 2020, in Suite 350 of the Occupational Safety and Health Standards Board Office, Sacramento, California, via teleconference at 844-992-5726, via WebEx/teleconference, in accordance with Executive Order N-29-20.

### II. PUBLIC MEETING

Mr. Thomas called indicated that this portion of the Board's meeting is open to any person who is interested in addressing the Board on any matter concerning occupational safety and health or to propose new or revised standards or the repeal of standards as permitted by Labor Code Section 142.2.

**Elizabeth Treanor, Phylmar Regulatory Roundtable,** stated that this is her last meeting, and she has enjoyed working with the Board throughout the years on many different rulemakings.

**Helen Cleary, Phylmar Regulatory Roundtable,** stated that she is taking Elizabeth's place at PRR and is looking forward to working with the Board.

Amalia Zimmerman Lommel, Good Farms LLC, asked the Board to review Sections 3205.3(c)(2) regarding the new bunk bed policy and the requirement of six feet between heads and 3205.4(c)(2) requiring transportation distance of three feet between people. These new regulations will hinder her organization's ability to invite new H-2A guest workers to harvest their crops. She also asked the Board to consider adding an exception to the regulation for farm workers who get vaccinated against COVID-19.

Karin Umfrey, Worksafe, stated that her organization supports the wildfire smoke standard that is scheduled for a vote today, but they feel it is not effective enough. The air quality index (AQI) trigger for respiratory protection should be lowered to an AQI of 101 and the trigger for required respirator use should be lowered to 300. The Division also needs to conduct more enforcement sweeps to ensure that employers are complying with the regulation. Gabriel Machabanski, Graton Day Labor Center, and Constance Barker, SEIU 2015, echoed Ms. Umfrey's comments.

Mishaal Gill, CA Immigrant Policy Center, stated that her organization supports the wildfire smoke standard, but they feel that it falls short in certain areas. There needs to be a requirement that employers inform workers about the new standard and wildfire alerts when they occur. The standard needs to provide clear guidance to employers regarding their responsibilities. The Division also needs to conduct more sweeping enforcement action to ensure employers are complying, as well as education and outreach so workers know their rights. Sasha Feldstein, CA Immigrant Policy Center, echoed Ms. Gill's comments.

**Kevin Bland, Ogletree Deakins,** thanked the Board for its hard work throughout the year.

**Dennis Pocekay, Petaluma City Council,** asked the Board to adopt the wildfire smoke standard because exposure to wildfire smoke aggravates asthma and other respiratory and cardiovascular diseases. He said that outdoor work is more physical than indoor work, so it is important to require employers to provide respiratory protection to their employees and inform their employees about this standard. This standard is also needed so that the Division may conduct robust enforcement to protect workers.

**Gabriel Machabanski, Graton Day Labor Center,** stated that his organization supports the wildfire smoke standard, but it needs to go further to protect workers. A broad reaching educational campaign that is culturally and linguistically relevant must be conducted for workers so that workers are informed of their rights. The Division must also provide clear guidance to employers and do more enforcement sweeps to make sure employers are complying.

The following individuals also commented in support of the wildfire smoke standard, but feel that it needs to be strengthened:

Nancy Zuniga, Instituto de Educacion Popular del Sur de California (IDEPSCA)

**Robert Moutrie, CA Chamber of Commerce,** stated that his organization is glad to see the wildfire smoke regulation moving along. They still have concerns regarding the feasibility of it that will hopefully be addressed in version 3.0. He also stated that the regulation does include some educational requirements.

# A. PROPOSED SAFETY ORDERS FOR ADOPTION

### 1. TITLE 8: GENERAL INDUSTRY SAFETY ORDERS

New Section 5141.1

**Protection from Wildfire Smoke** 

Mr. Berg summarized the history and purpose of the proposal and indicated that the proposal is now ready for the Board's consideration and vote.

**Ms. Stock** asked Mr. Berg to clarify when communication and training needs to be provided. **Mr. Berg** stated that the regulation only takes effect when the AQI for PM2.5 is 151 or greater and there is reasonable anticipation that it is from wildfire smoke, so communication and training does not need to happen until then.

**Ms. Burgel** asked Mr. Berg to explain why the Division did not lower the trigger to 101 for sensitive groups and to also discuss the pros and cons for lowering the trigger for mandatory respirator use to 300. **Mr. Berg** stated that the AQI of 151 was chosen in an effort to balance practicality with protecting the health of employees. He said that the Division would prefer to have the trigger be at 101, and they will be discussing that for future revisions. **Ms. Burgel** stated that not providing education to sensitive groups until the AQI hits 151 is a missed opportunity to protect them. **Ms. Stock** echoed Ms. Burgel's concerns regarding the AQI triggers.

**Ms. Stock** stated that waiting to provide education to employees about their rights under this standard until the event is happening is not optimal. She feels it would be best to include this information in regular training for employees who may possibly be exposed to wildfire smoke during their work. She would also like to see domestic workers included in this standard.

**Ms. Kennedy** stated that the triggers that the Division selected are in line with occupational limits for other worker categories who are also exposed to particulates in their work environments. She also suggested that the wildfire smoke regulation could be used as a driver for improving occupational exposure limits for all workers.

**Ms. Laszcz-Davis** stated that she echoes many of the comments made by the other Board Members and thanked the Division for their hard work on this standard. **Mr. Harrison** echoed Ms. Laszcz-Davis's comments.

### MOTION

A motion was made by Ms. Stock and seconded by Ms. Laszcz-Davis that the Board adopt the proposal.

A roll call was taken, and all members present voted "aye." The motion passed.

# B. <u>PROPOSED PETITION DECISION FOR ADOPTION</u>

1. Scott Swaaley, CEO

Petition File No. 580

Petitioner requests to amend title 8, section 2530.43 to clarify the existing anti-restart standard as well as add current Federal OSHA language to title 8, section 4001 to better align with Federal OSHA requirement (1910.213(b)(3)).

Ms. Shupe summarized the history and purpose of petition 580 and stated that the proposed decision is to deny the petition.

# **MOTION**

A motion was made by Mr. Harrison and seconded by Ms. Stock to deny the petition.

A roll call was taken, and all members present voted "aye." The motion passed.

# C. PROPOSED VARIANCE DECISIONS FOR ADOPTION

1. Consent Calendar

Ms. Shupe stated she is aware of no unresolved procedural issues regarding items A-S on the consent calendar, and she believes that those items are ready for the Board's decision on the question of adoption.

A motion was made by Ms. Laszcz-Davis and seconded by Mr. Harrison to adopt the consent calendar.

A roll call was taken, and all members present voted "aye." The motion passed.

# D. REPORTS

1. Division Update

Mr. Berg provided the following updates:

<u>COVID-19 Emergency Temporary Standard (ETS):</u> The Division will be holding a stakeholder meeting virtually tomorrow, December 18, at noon to get input for future advisory committee meetings and to make improvements and clarifications to the emergency temporary standard.

The Division continues to work on the following regulations and hopes to do rulemakings on them next year:

- Lead in Construction and General Industry
- Indoor Heat
- Antineoplastic Drugs
- Workplace Violence

**Ms. Laszcz-Davis** stated that she hopes the stakeholder meeting tomorrow for the COVID-19 ETS and advisory committee meetings in 2021 will be more interactive instead of just input only.

## 2. Executive Officer's Report

Ms. Shupe stated that on December 14, 2020, the Governor issued Executive Order N-84-20 which provides for the suspension of section 3205(c)(10) and (c)(11) only to the extent that they exceed the longer of any applicable quarantine or isolation period recommended by the CA Department of Public Health (CDPH) or a local health officer who has jurisdiction over the workplace. It does not impact the Board's rulemaking or ability to readopt the COVID-19 ETS as allowed for in the Administrative Procedures Act.

Ms. Shupe stated that the Board staff has hired Autumn Gonzalez to the attorney position. Ms. Gonzalez will start working on December 18, 2020.

Ms. Shupe stated that the Legislature will reconvene on January 4, 2021, and legislative briefings will resume again at the January Board Meeting.
