**OPINION AND DECISION
AFTER RECONSIDERATION**

Applicant petitioned for reconsideration of the Findings and Order issued by the workers' compensation administrative law judge (WCJ) in this matter on July 7, 2023. In that decision, the WCJ found that applicant did not sustain his burden of proof as to the reasonableness of the treatment relative to a continued Casa Colina Transitional Living Center Interdisciplinary Post-Acute Residential Rehabilitation Program with 4-6 hours of therapy, from April 1, 2023 through June 30, 2023, and was thus not entitled to such care.

We granted reconsideration to further study the factual and legal issues presented.

Subsequently, the Appeals Board has been advised that, while this matter has been pending on reconsideration, a proposed settlement has been reached. Therefore, as our Opinion and Decision after Reconsideration, we will rescind the decision from which reconsideration is sought, and return this matter to the trial level for the workers' compensation administrative law judge (WCJ) to consider the proposed settlement. If the WCJ does not approve the settlement, the WCJ may issue an order reinstating the original decision and any aggrieved person may timely seek reconsideration from the reinstated decision. This is not a final decision on the merits of any of the issues pending on reconsideration.

For the foregoing reasons,

IT IS ORDERED as the Decision After Reconsideration of the Workers' Compensation Appeals Board that the WCJ's decision of July 7, 2023 is **RESCINDED** and this matter be **RETURNED** to the trial level for further proceedings and decision by the WCJ.
